I pray each of you and your families are healthy and safe. We are now halfway through the year and as we enter the third quarter of 2021, the horrible COVID pandemic that has ravaged the world and caused the loss of so many lives continues to affect the way we live every day. Let's remember to uplift and give a helping hand until this pandemic is defeated. Our industry and Local thrives as construction projects in our area and our signatory contractors continue to be busy. Total work hours for 2019 was 3,381,426 and in 2020, hours were 3,537,181 which is a 4.6% increase. So far through the month of April 2021, reported hours put us on track with the previous year.

Local 600 remains strong, we continue to increase financially and in membership. Your Business Representatives remain focused on their duties, protecting our work jurisdiction and organizing new contractors to create work opportunities for our membership. Within the first six months of this year, four new contractors have become fully signatory by signing our Master Labor Agreement. Design Build Engineering, Paramount Builders, ANM Concrete Construction Inc. and Raymond L. Hayes Construction. Along with these, numerous Project Only and Apprentice Subscription Agreements have also been signed.

Our Funds are doing well with the help and guidance of our professional consultants which enables the Trustees to make solid decisions on behalf of our members. The Pension Fund has been certified in the green zone for the plan year 2021 and the Health and Welfare has seventeen months in reserves. Our Negotiating Committee secured a new four-year agreement with decent increases over the contract period. Locals 500 and 600 continue to work together daily to ensure all Cement Masons are represented from San Diego to San Luis Obispo.

The 2021-2025 Cement Masons Master Labor Agreement provides for a \$2.20 per hour increase effective July 1, 2021. The Union has determined to allocate the increase as follows: <b>Vacation: \$0.10 increase, Administration Dues: \$0.04 increase, Defined Benefit Plan (Pension): \$0.15 increase, Health &amp; Welfare: \$0.11 increase, Defined Contribution (IRA): \$0.25 increase and to Wages: \$1.55 increase.</b> <i>(Future increases: July 1, 2022 - \$2.25, July 1, 2023 - \$2.25 and July 1, 2024 - \$2.15; A predetermined amount of \$0.15 each year will be allocated to the Defined Benefit Pension) *</i>

## For Our Members and Families Who Cook

# HOG HEAVEN Smokin' Pork Chops



These smoked pork chops take almost no time to prep, and they cook quickly. The combination of spices and smoky flavor is delicious.

### Ingredients

- 1 Tbsp brown sugar, packed
- 2 Tbsp paprika
- 2 Tbsp garlic powder
- ½ Tbsp chili powder
- ½ tsp ground mustard
- ½ tsp Old Bay seasoning
- ½ tsp onion powder
- ½ Tbsp salt
- ½ tsp freshly ground black pepper
- 6 (3.3 lb total) pork chops, about 1 inch thick

### Directions

In a small bowl, mix the brown sugar and all of the seasonings together until smooth. Coat the pork chops on all sides with the mixture. Place the chops in a non metal dish, cover with cling wrap and refrigerate for 2 to 3 hours.

With your favorite wood, start up the smoker according to the manufacturer's instructions and raise the temperature to around 225 F. Cook the pork chops to a suggested internal temperature of 145 F when measured in the thickest part with a digital/smoker thermometer—about 50 to 60 minutes. Makes 6 servings.

## Things Members Should Know

Window dues for Local 600 members is one of the lowest within the Building Trades unions. Journeyman dues are set at \$21.00 per month, that amount is reduced to \$16.00 when the member pays by 7th day of the month or pays ahead. Apprentice dues are set at \$15.00 per month, and that amount is reduced to \$10.00 when the member pays by the 7th day of the month or pays ahead. After the 7th day the full amount is due. After the 3rd month of non-payment the member is considered delinquent and will be assessed a \$5.00 late charge. Being current is important for the member to be eligible for any death benefit to be paid to

a beneficiary. Any questions regarding window dues, please contact the Bell Gardens office.

### Update Your Address

It is very important the Local Union and Trust Fund offices have your current mailing address, beneficiary information and emergency contact on file. When you do not update this information, it will cause delays receiving your vacation check and correspondence from the Trust Fund regarding your health & welfare and pension benefits. If you plan to or have recently moved, married or divorced, contact the main office or your area office to receive a change of address form or beneficiary cards. Changes will only be honored in writing.

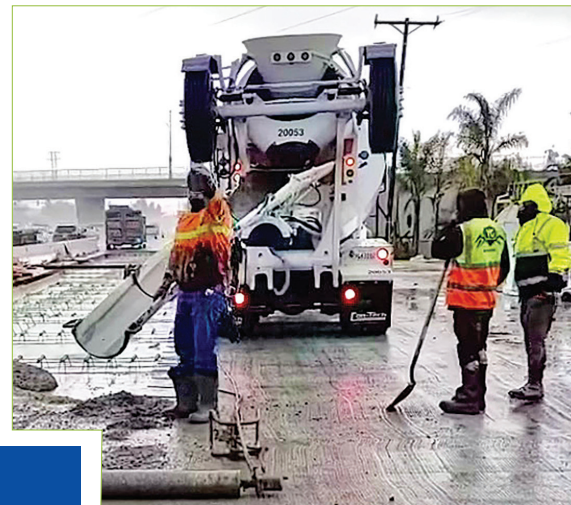
