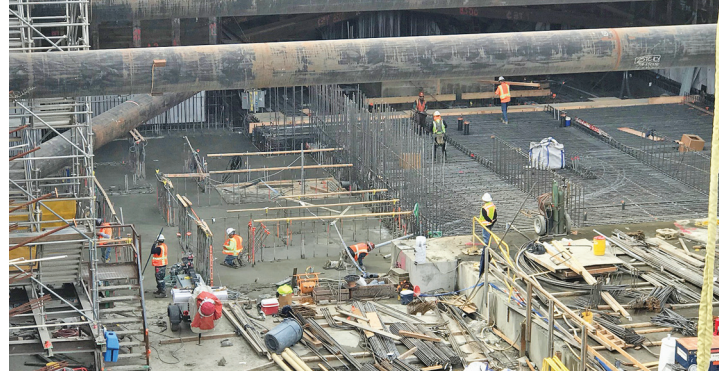

Super Nachos!



Ingredients

- 1 pound lean ground beef (Tyson Fresh Meats)
- 1 medium onion, finely chopped
- 1-2 tablespoons fresh garlic, minced
- Jalapeño pepper to taste
- 1 small green bell pepper, seeded and chopped
- 2-3 tablespoons chili powder (Watkins Seasoning or Durkee Spices & Seasonings)
- 1 ½ cups refried beans (Rosarita Refried Beans)
- 1 (16 ounce) jar salsa (Tostitos Chunky Salsa, Old El Paso, or Pace Salsa)
- 1 cup grated cheddar cheese
- Tortilla chips (Tostitos)
- Salt to taste (Diamond Crystal or Morton Salt)
- Black pepper to taste
- Sour cream (Alta Dena)
- Green onions, sliced
- Tomatoes, chopped (Eurofresh Vegetables or Sunripe Produce)
- Black olives, sliced

Directions

1. Cook ground beef. Add onions, garlic, Jalapeño peppers, green peppers, and chili powder. Stir beef until well browned.
2. Once beef is cooked, add beans, salsa and grated cheese. Continue to stir until beans and salsa are hot, and cheese has melted.
3. Place meat mixture on top of chips, add remaining toppings and guacamole as desired.

Chocolate Chip Ice Cream Sandwiches



Ingredients

- 2 ¼ cups flour (Gold Medal Flour)
- ¾ teaspoon baking soda
- 1 teaspoon salt (Diamond Crystal Salt or Morton Salt)
- 2 sticks or ½ pound softened butter (Land O' Lakes or Blue Bonnet Butter)
- 1 cup granulated sugar (Domino)
- ½ cup packed light brown sugar (Domino)
- 2 large eggs (Alta Dena or Horizon)
- 1 ½ teaspoons pure vanilla extract
- 2 cups semi-sweet chocolate (Nestle or Hershey's)
- Ice Cream (Breyer's or Good Humor Ice Cream)

Directions

1. Mix flour, baking soda and salt in bowl. Set aside
2. In a separate bowl, beat butter and sugars at medium speed for 3-4 minutes, then add eggs and vanilla while blending.
3. Add the flour mixture at low speed. Then stir in chocolate chips.
4. Cover the mixing bowl with plastic wrap and refrigerate for at least 30 minutes.
5. Shape into balls (2-inch or preferred size) and place onto cookie sheet a few inches apart from each other.
6. Bake for 12 to 15 minutes at 350°F. Once golden brown, let cool completely.
7. Scoop ice cream onto flat side of cookie, and top with another cookie. Use a butter knife to flatten, and add mini chocolate chips or sprinkles for decoration.
8. Hint: Have fun using assorted ice-cream flavors like mint-chocolate chip!

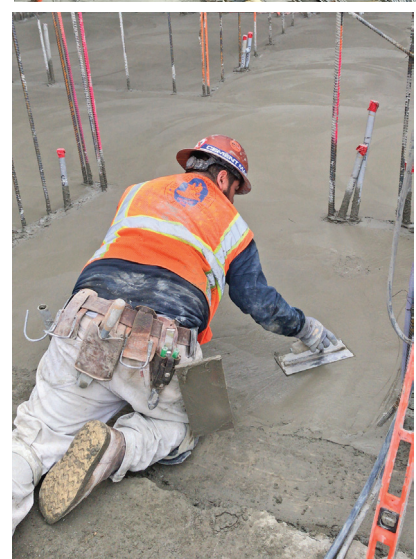
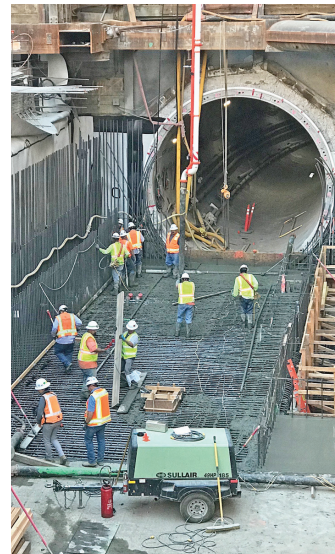
OSHA 10 Training 2020
